## Neffs UCC Preschool Health and Safety Plan 2022-2023 SY

Updated: August 15, 2022

The health and safety of our students and staff is our top priority. To this end, the preschool will institute additional mitigation measures based on guidelines from the CDC, the American Pediatric Association, as well as local and state health departments. The staff will work together to implement these measures and any updates will be sent to parents and available on our website. These plans are subject to change at any time, based on the most recent legal mandates and data available.

#### **General Guidelines**

RED PHASE- Local schools are directed to close for all in-person learning by either the district or the state government. If this occurs, the preschool will temporarily move to virtual learning until the board makes a decision on re-opening.

YELLOW PHASE- Neffs UCC Preschool will/will not close to in-person learning. The church will be consulted for additional guidance. Masks **may** be required when indoors.

**GREEN PHASE**- Neffs UCC Preschool is open for in-person learning. Updates will be communicated for any confirmed cases of COVID. If we reach 2 confirmed cases in a classroom within a week, the preschool will close for virtual learning and enhanced cleaning for a minimum of 5 days and a maximum of two weeks, per episode. Closure will be limited to the cohort group in which the exposure occurred, depending on Health Department recommendations. Masks **may** be required when indoors based on community spread and classroom case counts.

## **Mitigation Strategies**

- Only students and staff are allowed inside of the building except in the case of an emergency.
- It is recommended, but not required for staff and students to wear a mask when in the building.
- Keeping up to date on vaccinations, including vaccines to prevent COVID-19, is the best defenses to protect your child and his/her peers.

- When two classes of students are in the building at the same time, students
  will be divided into cohorts as much as possible to limit contact and
  minimize the spread of illness. There are exceptions when both classes will
  be in contact with each other such as recess, pick-up time, and lunch
  bunch.
- High-touch areas will be cleaned frequently throughout the day, and between cohort groups.
- Hand washing will occur before snack time, when coming in from the playground, after using the bathroom, and as needed.
- Students will use hand sanitizer when hand washing is not possible. A Hand sanitizer form must be signed by parents.

What to do if your child is exposed to someone who tests positive or if he/she tests positive

### **Exposed:** No need to quarantine IF SYMPTOM FREE.

1. Return to school wearing a well-fitted (KN95 or N95) mask indoors AND outdoors for 10 days. Test on day 5, if positive, follow steps below.

2. Students who cannot or will not wear a mask should continue to isolate for 10 days from time of exposure.

## **Tests Positive or Develop Symptoms:**

- 1. Consult the screening tool above.
- 2. Students who are vaccinated may return after 5 days with a negative test. Unvaccinated students may return after 10 days with a negative test.

If fever or major symptoms continue, stay home until 24 hours fever free without medication.

\*If your child develops a fever or symptoms of COVID he/she will be asked to wear a mask (school provided) if indoors, while waiting for emergency pick-up.

## **Drop-off and Pick-Up Procedures**

- Families will form a car line in the north lot for drop-off at the overhang by the double doors. Cars will line the perimeter of the lot, not blocking traffic, such that the cars face Route 873 when it is their turn.
- Upon pick-up, staff will place each child in the designated car, but families are required to pull into a parking spot to fasten car seats.
- If a family is late for drop-off, they will be asked to call 610-767-5327 to have a staff member come and get the child. If the child is in the downstairs classroom, the parent may be asked to move to the south lot.
- Pick up will occur via the same car line procedure as drop off unless a Remind text is sent out alerting you to a pick up in the Grove.
